Prior to the use of MCB-1925 Microbiocide in recirculating cooling tower systems, systems should be cleaned to remove bacterial slime and other deposits. An initial dosage of 5 fl. oz. of MCB-1925 Microbiocide per 30 to 45 ppm of MCB-1925 Microbiocide of water in the system. Repeat initial dosage until control is achieved. Additions of 2 to 5 fl. oz. of MCB-1925 Microbiocide per 15 to 45 ppm of water should be employed every 1 to 5 days, or as needed. The frequency of addition depends upon the relative amount of bleedoff and severity of the microbiological problem. Repeat initial dosage until control is evident.
