Algycide 440
in swimming pools, exterior spas, whirlpools, hot tubs, and minimum effectiveness pools, spas, whirlpools, hot tubs, and hot tubs with heavy growth of algae should be cleaned prior to using Algycide 440.
For pools having just visible algae growth add an amount of Algycide 440 fluid ounces of Algycide 440 per 10,000 gallons of water. Subsequent additions of Algycide 440 per 10,000 gallons of water should be made every 5 to 7 days after initial treatment for maintenance.

Spas, whirlpools, hot tubs, and decorative fountains should require an initial dose of 2 to 3 fluid ounces of Algycide 440 per 1000 gallons of water. For treatment of a fresh hot tub, or decorative fountain, add initially Algycide 440 per 1,000 gallons of 0.4 to 1 fluid ounces of Algycide 440 should be made every 5 to 7 days after initial treatment. Algycide 440 is compatible with chlorine chemicals used to treat pools, spas, and decorative fountains. Algycide 440 is compatible with alkaline pH. Algycide 440 decorative fountains treated with chlorine chemicals normally required. However, do not mix Algycide 440 with concentrated dry or liquid chlorine products.

STORAGE AND DISPOSAL

STORAGE: Keep container closed when not in use. Containers should be placed in a plastic bag and disposed of with clear water. All pesticides should be kept away from food.
