**General Weed Control**—Concentrate can be used to control most weeds for an extended period of time on non-cropland areas such as loading ramps, fence rows, railroad sidings, storage yards, parking lots, around building and industrial plant sites.

To control annual weeds and grasses such as foxtail, ryegrass, wildoats, crabgrass, chestgrass, broomsedge, ragweeds, lambquarter and turkey mullein, dilute one gallon of Concentrate to 9 gallons of water and apply 6 gallons of the diluted spray, per 1000 square feet.

For hard to kill perennial weeds and grasses such as Johnson grass, Salt grass, Bouncing Bet, Bracken fern, Horsetail, Smooth Brooms, Canada Bluegrass, purple-top quackgrass, broomsedge, aster dandelion, dog fennel, goldenrod, plainain and wildcarrot, dilute one gallon of Concentrate to 9 gallons of water and apply 10 gallons of diluted spray per 1000 square feet.

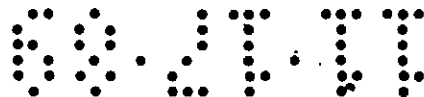
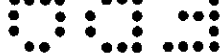
**STORAGE AND DISPOSAL**

**GENERAL:** Do not contaminate water, food, feed, fertilizer, or other pesticides by use, storage, or disposal. If damaged, leaking, or spilled, dispose of as below.

**STORAGE:** Keep in upright, tightly closed original container in a cool, dry, locked storage area away from flames, sparks, sunlight, other chemicals, and other sources of ignition, heat, degradation, or contamination.

**PESTICIDE DISPOSAL:** Pesticide wastes are toxic. Improper disposal of excess pesticide, spray mixture or rinsate is a violation of Federal law. Dispose of excess or waste pesticide by use according to label directions, or contact your State Pesticide or Environmental Control Agency, or the Hazardous Waste representative at the nearest EPA Regional Office for guidance.

**CONTAINER DISPOSAL:** Triple rinse (or equivalent). Then offer for recycling or reconditioning or puncture and dispose of in a sanitary landfill, or by other approved State and local procedures. Rinsed plastic & paper-reinforced plastic containers may also be disposed of by incineration or, if allowed by State and local authorities, by burning. If burned, stay out of smoke.

It is a general herbicide for control of perennial grasses, weeds and brush. Results are slow to appear and will not become apparent until it reaches the root structure. The degree of effectiveness and its duration will vary with the concentration applied, soil type and rainfall.

**CAUTION:** Do not let the liquid come in contact with susceptible plants, such as vegetables, flowers, fruit trees, ornamentals, cotton, grapes, or other desirable plants or allow spray mists to drift onto these plants. (Coarse sprays are less likely to drift). Thoroughly clean spray equipment before using for other purposes. Do not store near fertilizers, seeds, insecticides, or fungicides. Do not apply to areas underlain by roots of desirable trees and shrubs. Do not contaminate water used for irrigation or domestic purposes. Do not reuse this container for other purposes. Destroy by perforating or crushing. Bury or discard in a safe place.
