

DIRECTIONS FOR USE

It is a violation of Federal law to use this product in a manner inconsistent with its labeling.

MB-10 is used for recirculating cooling tower systems and industrial microbiological slime. Prior to the use of MB-10 industrial and/or commercial recirculating cooling towers should be cleaned to remove algal growth, microbiological slime, and other deposits. Initial slug addition of 12.0 to 17.9 fl. oz. of MB-10 per 1000 gal. of water to provide 100 to 150 ppm, based on total weight of water until control is evident. Make subsequent slug additions of MB-10 per 1000 ppm MB-10 every 2 days. The frequency of addition depends upon the relative amount of microbiological problem. Slug additions should be made to recirculating cooling tower systems.

MB-10 is used for recirculating cooling tower systems which maintain effective mist-eliminating components. Cleaned to remove bacterial slime and other deposits. Initial dosage of 35.9 fl. oz. of MB-10 per 1000 gallons of water is recommended. Repeat initial dosage until control is achieved. 21.0 to 35.9 fl. oz. of MB-10 per 1000 gallons of water should be employed every 1 to 5 days. The frequency of addition depends upon the relative amount of bleedoff. Slug additions may be made to the sump or the recirculating system.

STORAGE AND DISPOSAL

Do not contaminate water, food, or feed by storage or disposal. STORAGE: Do not expose to extreme temperatures. Do not stack drums should be placed in overpack drums for disposal. Spills should be cleaned up in a sanitary landfill. Keep container closed when not in use.

PESTICIDE DISPOSAL: Pesticide wastes are acutely hazardous. If these wastes cannot be disposed of by the above instructions, contact your State Pesticide or Environmental Control Agency or your EPA Regional Office for guidance.
