DIRECTIONS FOR USE

It is a violation of Federal law to use this product in a manner inconsistent with its labeling.

MB-25 is used for recirculating cooling tower systems and industrial microbiological slime. Prior to the use of MB-25 industrial and/or commercial recirculating cooling towers should be cleaned to remove algal growth, microbiological slime, and an initial slug addition of 4.5 to 6.8 fl. oz. of MB-25 per 1000 gal. of water to provide 40 to 60 ppm MB-25 based on total weight of water in the system until control is evident. Make subsequent slug additions of MB-25 per 1000 gal. of water every 2 to 5 days. The frequency of addition depends upon the relative amount of microbiological problem. Slug additions should be made to recirculating cooling tower systems MB-25

MB-25 is used for which maintain effective mist-eliminating components. Cleaned to remove bacterial slime and other deposits. A slug addition of 13.6 fl. oz. of MB-25 per 1000 gal. of water is recommended. Repeat initial dosage until control is evident. 7.9 to 13.6 fl. oz. of MB-25 per 1000 gallons of water should be employed every 1 to 5 days. The frequency of addition depends upon the relative amount of bleedoff and microbiological problem. Slug additions may be made to the sump or the water treatment system.

STORAGE AND DISPOSAL

Do not contaminate water, food, or feed by storage or disposal. **STORAGE:** Do not expose to extreme temperatures. Do not stack more than 10 drums in a row. Drums should be placed in overpack drums for disposal. Spills should be cleaned up in a sanitary landfill. Keep container closed when not in use. **PESTICIDE DISPOSAL:** Pesticide wastes are acutely hazardous. Improper disposal, mixing, or reuse is a violation of Federal Law.
