It is a violation of federal law to use this product in a manner inconsistent with its label.

DIRECTIONS FOR USE

For a new pool or for spring cleaning, add 1.0 ppm (1.0 oz. per 100 gallons of water) of sodium hypochlorite solution. This dosage is based on weight.

FOR POOL MAINTENANCE

A) Adjust pool water pH to 7.2-7.6.
B) Add manually or by automatic chlorinator at a rate of 0.6 to 1.0 ppm. One 1.0 ppm available chlorine solution will maintain 0.6 to 1.0 ppm chlorine and number of swimmers. Chlorine residual should be maintained at 0.5 ppm.

NOTE: This product degrades in sunlight. Increase dosage, as necessary, to maintain residual chlorine.

STORAGE AND DISPOSAL

Store in a cool, dry place, away from direct sunlight. In case of spill, do not breathe vapors. Rinse empty container with water. Do not reuse. Do not discharge to manufacturer or discard in an approved land fill. Product diluted with water and disposed of as waste. Do not use to dilute food or feed by storage.
