DIRECTIONS FOR USE

It is a violation of Federal law to use this product in a manner inconsistent with its labeling.

Microbiocide 200 is used for cleaning recirculating cooling tower systems and industrial microbiological slime. Prior to the use of Microbiocide 200 on industrial and/or commercial recirculating cooling towers, the towers should be cleaned to remove algal growth, microbiological slime, and other deposits. An initial slug addition of 9.5 to 14.2 fl. oz. of Microbiocide 200 per 1000 gal. of water to provide 80 to 120 ppm Microbiocide 200, based on total weight of water in the system, until control is evident. Make subsequent slug additions of Microbiocide 200 per 1000 gal. of water (ppm Microbiocide 200) every 2 to 5 days. The frequency of addition depends upon the relative amount of biological growth and the microbiological problem. Slug additions should be made until control is evident.

Microbiocide 200 is used for cleaning cooling towers which maintain effective mist-eliminating components. Prior to the use of Microbiocide 200 to clean cooling towers, the towers should be cleaned to remove bacterial slime and other deposits. An initial slug addition of 28.4 fl. oz. of Microbiocide 200 per 1000 gal. of water is recommended. Repeat initial dosage until control is evident. Subsequent slug additions of 16.5 to 28.4 fl. oz. of Microbiocide 200 per 1000 gallons of water should be employed every 1 to 5 days. The frequency of addition depends upon the relative amount of bleedoff and the microbiological problem. Slug additions may be made to the sump or the water system.

STORAGE AND DISPOSAL

Do not contaminate water, food, or feed by storage or disposal.

STORAGE: Do not expose to extreme temperatures. Do not stack more than 10 drums. Drums should be placed in overpack drums for disposal. Spills should be cleaned up and disposed of in a sanitary landfill. Keep container closed when not in use.

PESTICIDE DISPOSAL: Pesticide wastes are acutely hazardous. Improper disposal of empty containers as a violation of Federal Law. If these wastes cannot be disposed of by other procedures approved by state and local authorities, contact your State Pesticide or Environmental Control Agency, or your EPA Regional Office for guidance.
