

DIRECTIONS

It is a violation of Federal law to use this product inconsistent with its labeling.

MB 1006 is used in cooling tower systems and industrial air-washing. Prior to the use of MB1006 recirculating cooling tower systems, systems with microbial slimes, and other deposits. Then add 3.0 fl. oz. of MB 1006 to 20 to 30 ppm of MB 1006 of water in the system. Repeat initial dosage until addition of 1.0 to 3.0 fl. oz. of MB 1006 per gal. of water (10 to 30 ppm) every 1 to 3 days or as needed. The frequency of additions depends upon the severity of the microbiological growth in the sump of recirculating cooling tower system.

MB 1006 is used to maintain effective mist-eliminating components cleaned to remove bacterial slime and other deposits. Add 6.0 fl. oz. of MB 1006 to 3.5 to 6.0 fl. oz. of MB 1006 per 1000 gal. of water treated. This should be added every 1 to 5 days, depending upon the relative amount of bleedoff and additions may be made to the sump or the water in the sump.

MB 1006 is used to control bacteria, including sulfate-reducing organisms, in waterflooding operations. In systems fouled with bacteria, MB 1006 should be added as a continuous treatment. Add 8 to 16 ppm (0.83 to 1.6 fl. oz. of MB 1006 per 1000 gal. of water treated). This should be added every 1 to 5 days, depending upon the relative amount of bleedoff and additions may be made to the sump or the water in the sump.

MB 1006 is also used to control bacteria in water-based drilling muds, completion fluids, and based drilling fluids containing starch, gums, and other additives for purposes of MB 1006 is used at a concentration of 0.06 to 0.1 gal. per 100 barrels of fluid.

STORAGE AND DISPOSAL
