

DIRECTIONS FOR USE

It is a violation of Federal law to use this product inconsistent with its labeling.

Slimetrol N-175 is used in recirculating commercial and industrial water cooling systems must be cleaned to remove algal growth, other deposits. An initial slug addition of 3.3 Slimetrol N-175 per 1000 gallons is recommended. Repeat initial dosage until control is evident. Subsequent slug additions of 1.1 to 1.1 Slimetrol N-175 per 1000 gallons of water every 1 to 5 days, or as needed. The frequency of additions should be made in the sump of water cooling systems.

Disodium cyanodithioimidocarbonate 7.35 %

Potassium N-methyldithiocarbamate 10.15 %

HAZARDS TO HUMANS AND DOMESTIC ANIMALS
