DIRECTIONS FOR USE

It is a violation of Federal law to use this pesticide in a manner inconsistent with its labeling.

Slimetrol N-100
in recirculating commercial and industrial water treatment systems must be cleaned to remove algae and other deposits. An initial slug addition of Slimetrol N-100 per 1000 gallons is recommended. Repeat initial dosage until control is achieved. Subsequent slug additions of 2.3 Slimetrol N-100 per 1000 gallons are recommended every 1 to 5 days, or as needed. The frequency of additions should be made in the sump of water.

STORAGE AND HANDLING

Do not contaminate water, food, or feed by storage or disposal. STORAGE: Do not expose to extreme temperatures. Do not store more than five drums high. Drums should be opened in well-ventilated areas. Damaged drums should be placed in overpack and disposed of. Do not be absorbed in sawdust or sand and dispose of in a sealed container closed when not in use.

PESTICIDE DISPOSAL: Pesticide wastes, sludge, or excess pesticide, spray mixture, or rinsate is a hazardous waste and cannot be disposed of by use according to local, State Pesticide or Environmental Control Agency, or representative at your EPA Regional Office.
