

DIRECTIONS FOR

It is a violation of Federal law to use this product inconsistent with its labeling.

GMB-580 is used in recirculating commercial and industrial water systems must be cleaned to remove algal growth and other deposits. An initial slug addition of 10 GMB-580 per 1000 gallons is recommended. Repeat initial dosage until control is effected. Subsequent slug additions of 3.4 GMB-580 per 1000 gallons every 1 to 5 days, or as needed. The frequency and relative amount of bleedoff and the severity of the additions should be made in the sump of water.
