2) Based on toxicity ranking per the acute toxicity review, the First Aid statements should be placed on the label in the following order:

3) Per the acute toxicity review, the Hazards to Humans and Domestic Animals must be revised to read:

"DANGER

Corrosive. Causes irreversible eye damage. May be fatal if swallowed. May be fatal if inhaled. Harmful if absorbed through skin. Do not get in eyes, on skin or on clothing. Do not breathe dust. Prolonged or frequently repeated skin contact may cause allergic reactions in some individuals."

Revise the sentence "Wear goggles or face shield and dust mask while handling, mixing or loading" to "Wear goggles or face shield and a dust/mist filtering respirator (MSHA/NIOSH approval number prefix TC-21C), or a NIOSH approved respirator with any N, R, P, or HE filter while handling, mixing, or loading." The remaining language "Avoid contact with skin...sido explicado ampliamente" may remain in this section on the label.

4) You must list out the exact uses in the following section that this product may be formulated into: "Only for formulation into fungicides, bactericides, antifouling coatings, or wood preservatives in terrestrial non-food, wood/wood products, aquatic uses."
