GENERAL INSTRUCTIONS

CHAMPION SEED DRESSING should be used as described below. CHAMPION SEED DRESSING is specially formulated for use as a seed protectant. It is compatible with many fungicides and other materials commonly used as seed disinfectants. Because of the wide number of combinations possible with other pesticides, it is recommended that specific mixtures be evaluated before use with this product. The following specific instructions are based on general applications. The recommendations of State Agricultural Experiment Stations should be closely followed. The Federal Government and most states have seed laws or regulations requiring that certain caution statements be affixed to containers used to ship or store treated seed. Do not use treated seed for food, feed or oil purposes.

STORAGE AND DISPOSAL

Do not contaminate water, food or feed by storage or disposal. Wastes resulting from the use of this product may be disposed of on site or at an approved waste C.:-np facility.

WifeAre BARLEY Bacterial Leaf blight (Pseudomonas syringae), Bacterial Leaf Streak (Xanthomonas translucens), Common Bunt (Tilletia caries), Apply CHAMPION 655D DRESSING at the rate of 4 fluid ounces of formulated product per 100 pounds of seed. It should be diluted with equal parts of gate period applying.
