The labeling referred to above, submitted in connection with registration under the Federal Insecticide, Fungicide, and Rodenticide Act, as amended, is acceptable provided that the following changes are made:

The Human Hazards Statement should be:

"Corrosive, causes irreversible eye damage. Harmful if swallowed, absorbed through the skin or inhaled. May cause skin sensitization reactions in certain individuals. Avoid contact with skin, eyes or clothing. Avoid breathing dust. Protective clothing, including goggles, should be worn. Wash thoroughly with soap and water after handling. Remove contaminated clothing and wash before reuse."

The Statement of Practical Treatment must include:

"If swallowed: Drink promptly a large quantity of milk, egg white, gelatin solution, or, if these are not available, large quantities of water. Avoid alcohol. Note to Physician: Probable mucosal damage may contraindicate the use of gastric lavage."

The Environmental Hazards Statement should be:

"This pesticide is toxic to fish and aquatic organisms. Do not discharge effluent containing this product into lakes, streams, ponds estuaries, oceans or public water unless this product is specifically identified and addressed in an NPDES permit. Do not discharge effluent containing this product into sewer systems without previously notifying the sewage treatment plant authority.
