- c. Under the "Directions for Use" section, the word "or" after "fungicides" should be deleted. The statement should read: "Use only in formulating into agricultural fungicides for use on pecan trees, potatoes, and/or sugar beets."
- 3. Submit one copy of the revised final printed label for the record.

If these conditions are not complied with, the registration will be subject to cancellation in accordance with FIFRA section 6(e). Your release for shipment of the product constitutes acceptance of these conditions.
