The amended label referred to above, submitted in connection with registration under the Federal Insecticide, Fungicide and Rodenticide Act as amended is acceptable provided the following changes are made:

- Remove "ROSACEAE HOME GARDEN APPLE TREES, HOME GARDEN PEAR TREES" from the list of crops and/or use sites. (Page 3)

Roses, apples and pears are already mentioned in the crop and/or use site list; these sites seem redundant and may be confusing.

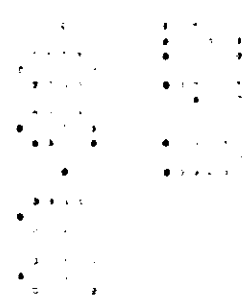

### STREPTOMYCIN SULFATE TECHNICAL

#### PRECAUTIONARY STATEMENTS HAZARDS TO HUMANS AND DOMESTIC ANIMALS WARNING

May cause allergic skin reactions. Do not breathe dust. May be absorbed through skin. Do not get in eyes. Wear goggles or face shield and dust mask while handling, mixing or loading. Avoid contact with skin, eyes or clothing. Wash thoroughly with soap and water after handling. Remove contaminated clothing and wash before reuse.

#### FIRST AID
