The amended label referred to above, submitted in connection with registration under the Federal Insecticide, Fungicide and Rodenticide Act as amended is acceptable provided the following changes are made:

1. Under the header HAZARDS TO HUMANS AND DOMESTIC ANIMALS:
 - a. Replace "May cause allergic skin reactions." with "Prolonged or frequently repeated skin contact may cause allergic reactions in some individuals."
 - b. Change "Wear goggles or face...." to "Wear chemical resistant gloves made of any waterproof material, goggles or face...."

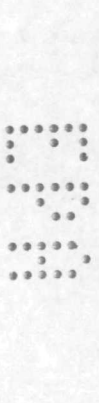

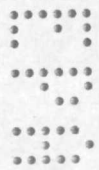
