In order to protect health and the environment, the Administrator, on his motion, may at any time suspend or cancel the registration of a pesticide in accordance with the Act. Based on your response to the Reregistration Eligibility Decision, EPA has reregistered the product listed above. This action is taken under the authority of section 4(g)(2)(C) of the Federal Insecticide, Fungicide, and Rodenticide Act, as amended. Reregistration under this section does not eliminate the need for continual reassessment of pesticides. EPA may require submission of data at any time to maintain the registration of your product.

The Confidential Statement of Formula (CSF) dated July 6, 2009 is accepted and replace all CSFs previously accepted for this product. The CSF dated June 10, 2009, is not accepted due to its having been replaced.

The labeling referred to above, submitted in connection with registration under the Federal Insecticide, Fungicide and Rodenticide Act (FIFRA), as amended, is accepted subject to the comments in this letter.

Label Changes for EPA Reg. No. 55206-1

The changes identified below must be made to the proposed label that is marked "Revised 062609" which was submitted to the Registration Division on August 17, 2009. The label (also marked "Revised 062609") which was submitted for product reregistration is not accepted because it was supplanted by a more recent submission.

1. In the "**FORMULATORS ARE RESPONSIBLE ... PRODUCT**" line directly above the statement of ingredients, replace "**PRODUCT**" with "**PRODUCTS.**"
2. In the statement of ingredients, footnote the term used for the active ingredient ("Mineral Oil") with the phrase "Contains petroleum distillates".
3. In the "**FIRST AID**" box, after the sentence "Have the product container or label with you when ... treatment", add the sentence "You also may contact 1-800-xxx-xxxx for emergency medical treatment information." You are responsible for identifying and inserting an appropriate telephone number.

The "**FIRST AID**" box should be subdivided by inserting lines between the sets of bulleted items that pertain to each route of exposure ("**IF SWALLOWED:**", "**IF ON SKIN OR CLOTHING:**", "**IF IN EYES:**", and "**IF INHALED:**"), per PR Notice 2001-1.

4. Change the "**NOTE TO PHYSICIAN:**" text to read as shown below.

This product contains petroleum distillates and may pose an aspiration pneumonia hazard.

5. Restore the words "**HAZARDS TO HUMANS AND DOMESTIC ANIMALS**" so that they appear directly under "**PRECAUTIONARY STATEMENTS**" and above "**CAUTION**".
6. In the "**DIRECTIONS FOR USE**" section, replace "This product is intended for formulation into end-use products for:" with "This product may only be used to formulate end-use products labeled for:". In the "Spray use" list, delete the vague expression "fruit trees" and replace "all citrus" with a list of specific types of citrus trees.
7. The addition of "kiwifruit" to the crops in the "Spray use" list proposed via your submission of August 17, 2009, is accepted.
8. In the sentence that comes immediately below the heading "**STORAGE AND DISPOSAL**" ("Do not contaminate water, food, or feed by storage **and** disposal"), replace "and" with "or".

9. Revise the “**CONTAINER DISPOSAL:**” paragraph to be consistent with 40 CFR §156 Subpart H and PR Notice 2007-4, as revised April 29, 2008. Note that distinct statements are needed depending upon the sizes of containers used and whether they are refillable. The master label must indicate the statements that are proposed to be used for each type and size range of container. As this product is for manufacturing purposes only, the statements used should not refer to application equipment. When revising this paragraph, be sure to retain text pertaining to the ultimate disposal of containers.

10. The company name --BVA Oils, Inc. -- indicated on the label and in other recent correspondence for this product differs from the name B V Associates, Inc., that our records show to be linked to the company number “55206”. Our records further show that the company number “70589” is linked to BVA Oils (which has a postal address similar to that for B V Associates). If our records are reversed on this point, please inform us immediately so that we can make the needed changes. If our records are correct, you will have to change the company name on the label for this product to B V Associates or formally request to transfer the registration for this product from B V Associates to BVA Oils.

11. It is recommended that your company’s telephone number be provided underneath the company’s address.
