2. Make the labeling changes listed below before you release the product for shipment:
 - a. Add the phrase "EPA Registration No. 55206-3."
 - b. The child hazard warning "Keep Out of Reach of Children" must be placed above the signal word of your product's label. Please note and comply with the "type size requirements." A copy of "Labeling Requirements of FIFRA, as amended" is enclosed for your use.
 - c. Since your labeling is for Formulating Use Only, delete the claims "For Fruit Trees, Shade Trees, Shrubs, and Sweet Corn."
 - d. Delete from the labeling the following:

- e. 40 CFR 162.10 requires that pesticides bear appropriate storage and disposal label statements. Specific storage instructions are not prescribed. Each registrant must develop his own storage instructions. Likewise, the label of all products must bear explicit instructions about pesticide disposal. For your use, we are also enclosing PR Notice 83-3 which addresses the Storage and Disposal Label Statements. We suggest that the following wording be included under the Storage and Disposal section of your label. However, we emphasize that this suggested wording is not to preclude any wording you may appropriately construct to meet the labeling requirements.

Example:

STORAGE AND DISPOSAL

1. Prohibitions: Do not contaminate water, food, or feed by storage or disposal. Open dumping is prohibited.
2. Storage: Store in a cool, dry, locked place out of the reach of children.
3. Pesticide Disposal: Pesticide, or rinse solution that cannot be used according to label instructions must be disposed of according to applicable Federal, state, or local procedures.
4. Container Disposal: Triple rinse or equivalent. Then offer for recycling or reconditioning, or puncture and dispose of in a sanitary landfill, or by other approved state and local procedures.

- g. In the precaution section of the label, include:

PRECAUTIONARY STATEMENTS

Harmful if swallowed.

Avoid breathing vapors.

Wash hands after using.

Avoid contamination of food or food stuffs.

h. Include a Statement of Practical Treatment to read as follows:

STATEMENT OF PRACTICAL TREATMENT

If swallowed: do not induce vomiting. Contact a physician immediately.

If on skin: wash with soap and water.

If in eyes: flush with water.

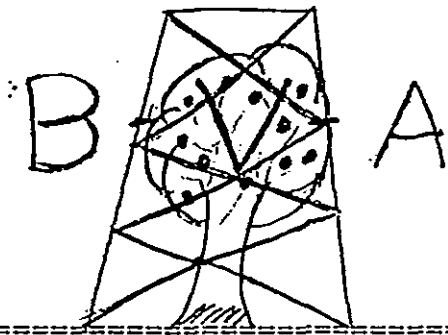
3. Submit five (5) copies of your final printed labeling before you release the product for shipment. Refer to the A-79 Enclosure for a further description of final printed labeling.

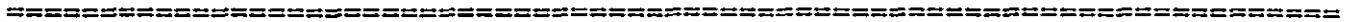

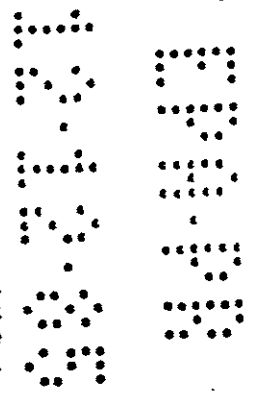
