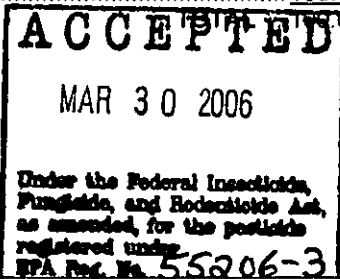

FIRST AID
