**GENERAL CLA**

It is a violation of federal law to use this product in a manner inconsistent with its labeling.

**DIRECTIONS FOR SWIMMING POOL CHLORINATION**

For a new pool or for spring start-up, superchlorinate with (16 flu. ozs.) of sodium hypochlorite solution for each 1000 gallons of water. This dosage is equivalent to 5 ppm available chlorine by weight.

**FOR POOL MAINTENANCE**

A) Adjust pool water pH to 7.6 - 7.2 range and maintain. B) Add manually or by a feeder device, sodium hypochlorite solution at a rate to maintain an available chlorine of 0.5 to 1.0 ppm. One half pint (8 flu. ozs.) of hypochlorite solution for each 6000 gallons of water will maintain 1.0 ppm available chlorine by weight. Frequency of application to maintain 0.5 to 1.0 ppm available chlorine will depend on the number of swimmers. Use test kit to measure and chlorine residual are in the proper range.

**NOTE:** This product degrades with age. Use a chlorine test kit to increase dosage, as necessary, to obtain the required level of available chlorine.

**STORAGE AND DISPOSAL:** Store in a cool, dry area away from direct sunlight. In case of spill, flood area with large quantities of water. Rinse empty container thoroughly with water and return to manufacturer or discard by placing in trash collection area approved land fill. Product or rinsate that cannot be diluted with water and disposed of in a sanitary sewer. Do not use as an invertebrate food or feed by storage, disposal or cleaning or other use.
