The amended label referred to above, submitted in connection with registration under the Federal Insecticide, Fungicide and Rodenticide Act as amended is acceptable provided the following changes are made:

- 1) On page 4, within the "Crop Use Directions" table, 2nd column, under the "Application Rate of Proplant Turf and Ornamental Fungicide." heading for "Curative Treatment" revise the sentence to read "Curative Treatment" 3-4 fluid ounces per 1,000 sq. ft. in 2-5 gallons of water".
- 2) On page 5, within the "Crop Use Directions" for "Ornamentals" under the heading for "Restrictions" correct the spelling of "Restrictions" to "Restrictions".

It may be used after germination to control Pythium damping-off in turf, or on established turf to prevent or control Pythium Blight. PROPLANT TURF AND ORNAMENTAL FUNGICIDE does not afford broad-spectrum disease control for *Rhizoctonia* spp. (Brown Patch), *Sclerotinia* spp. (Dollarspot), or *Helminthosporium* spp. (Leafspot). Use a broad-spectrum fungicide if these diseases coexist with Pythium Blight.

PROPLANT TURF AND ORNAMENTAL FUNGICIDE is also labeled for prevention of root rot and damping-off caused by *Pythium* spp. and *Phytophthora* spp. at all stages of ornamental propagation.
