

DIRECTIONS FOR USE

It is a violation of Federal law to use this pesticide in a manner inconsistent with its labeling.

S-39 is used in recirculating commercial and industrial water systems must be cleaned to remove algal growth and other deposits. An initial slug addition of 5 S-39 per gallon is recommended. Repeat initial dosage until control is achieved. Subsequent slug additions of 1.7 S-39 per 1000 gallons every 1 to 5 days, or as needed. The frequency of additions should be made in the sump of water.

STORAGE AND DISPOSAL

Do not contaminate water, food, or feed by storage or disposal. STORAGE: Do not expose to extreme temperatures. Do not store in five drums high. Drums should be opened in a well-ventilated area. Damaged drums should be placed in overpacks. Do not be absorbed in sawdust or sand and disposed of in a container closed when not in use.

PESTICIDE DISPOSAL: Pesticide wastes, sludges, excess pesticide, spray mixture, or rinsate is a hazardous waste cannot be disposed of by use according to local, State Pesticide or Environmental Control Agency, or representative at your EPA Regional Office for disposal.
