DIRECTIONS FOR USE

It is a violation of Federal law to use this product in a manner inconsistent with its labeling.

MWJ 3001 is used in recirculating commercial and industrial water cooling systems must be cleaned to remove algal growth and other deposits. An initial slug addition of 6.9 MWJ 3001 per 1000 gallons is recommended. Repeat initial dosage until control is evident. Subsequent slug additions of 2.3 MWJ 3001 per 1000 gallons every 1 to 5 days, or as needed. The frequency of additions should be made in the sump of water cooling
