On behalf of our client Maril Products Inc. enclosed is a notification in follow up to our (Final Printed Labeling) submitted on November 9, 2007 for the above mentioned product. This is being submitted in response to the State of New York's discussions with the Agency (see attached New York letter dated December 6, 2007) to our client.

Changes reflected in this Notification

- 1. Deletion of the sentence "This product has been used by Visiting Nurse Associations, Home Care Organizations, and Hospital Home Rehabilitation programs since 1974."
- 2. Increase in text size In rechecking previous label and the requirements in 40 CFR "Keep Out of Reach of Children" has been increased to 8pt and "DANGER" to 12pt.
- 3. Spelling Error "bls" has been changed to "lbs".
- 4. Replacement of word "dump" has been replaced with "discard".

We have attached one (1) version of the amended labeling with the added and revised text circled and initialed, along with two (2) clean copies of labeling without the markings.
