

DIRECTIONS FOR USE

It is a violation of Federal Law to use this product in a manner inconsistent with its labeling.

This product is not to be used as a terminal sterilant/high level disinfectant on any surface or instrument that (1) is introduced directly into the human body, either into or in contact with the bloodstream or normally sterile areas of the body, or (2) contacts intact mucous membranes but which does not ordinarily penetrate the blood barrier or otherwise enter normally sterile areas of the body. This product may be used to pre-clean or decontaminate critical or high level disinfection.

Control III Elite is specifically designed for the cleaning and disinfection of non-critical medical devices such as bed frames, wheel chairs, physical therapy equipment and other hard non-porous environmental surfaces in hospitals, nursing homes, durable medical equipment suppliers, doctors offices, schools, gymnasiums, homes and animal clinics. Control III Elite may also be used to pre-clean or decontaminate instruments in hospitals or other medical facilities prior to sterilization or high level disinfection.
