- c. Under "Keep Out of Reach of Children", Add the referral statement, "See other panels for additional precautionary information".
- d. Per PR Notice 2001-1, change the heading "Statement of Practical Treatment" to "First Aid Statement". Due to the toxicology profile, you may choose to exclude: "If inhaled ...", "If on skin ...", and "If in eyes ..." statements from the "First Aid Statement".
- e. Revise the Precautionary Statements to read: "Hazard to Humans and Domestic Animals"; Caution: "Harmful if swallowed. Wash thoroughly with soap and water after handling and before eating, drinking, chewing gum, or using tobacco".



With the water turned off at the faucet, attach a garden hose to the sprayer adapter. Make sure the hose is firmly attached and the sprayer is in the off position. Turn the water supply on at the faucet. Water pressure will build in the hose. To apply the product, turn the sprayer control to the on position. For best results, hold the sprayer and plastic container level and direct the sprayer in a sweeping side-to-side movement on lawns, landscaping and shrubs. Water and Double O Six ME are now being mixed at the proper rate. One gallon of diluted product (0.6 ounces of concentrate) will cover 100 square feet.

Ant and Fire Ant Mound Treatment

Mix 4 ounces of Double O Six ME Insecticide/miticides in one gallon of water to make a 10.009% solution. Apply 1 to 2 gallons of diluted Double O Six ME to each mound area by sprinkling the mound until it is wet. Also apply diluted product to a four foot diameter circle around the mound. Use the higher volume for mounds larger than 12" in diameter.
