- 3. You will submit/cite all data required for registration/ reregistration of your product under FIFRA section 3(c)(5) or 4(a) when the Agency requires all registrants of similar products to submit such data.
- 4. You will submit production information (pounds or gallons produced) for this product for the fiscal year in which the uses are conditionally registered, in accordance with FIFRA section 29. The fiscal year begins October 1 and

- 5. You will make the following labeling change before you release the product for shipment:
  - a. Add the phrase "EPA Registration No. 55638-17".
  - b. Under the heading Directions for Use, add "Only for Formulation into Biofungicide End-use Products For (1) The following uses: application to apples, cucurbits, grapes, ornamentals, strawberries and tematoes; (2) Uses for which USEPA has accepted the required data and/or citations of data that the formulator has submitted in support of registration; and (3) Uses for experimental purposes that are in compliance with USEPA requirements." Refer to PR Notice 91-8.
  - c. Based on the nature of the inert ingredients, a dust mask should be used when handling this product. Add a statement that "Dust/mist filtering respirator (NIOSH/MSHA appioval number prefix TC-21C" be used when handling the product.
- 6. The review of the product chemistry data stated that there was a possibility of addition of other inert ingredients such as "polysaccharide gums or gelatin". These substances may not be added to the product formulation unless a revised Confidential Statement of Formula is submitted.
- 7. Submit five copies of the final printed labeling before you release the product for chipment.

If these conditions are not complied with, the registration will be subject to cancellation in accordance with FIFRA sec (e). Your release for shipment of the product constitutes acceptance of these conditions.
