

BFX 77

is used to control bacteria in metalworking fluids employed as lubricating and processing of metals.

It is recommended that BFX 77 be added to the diluted metalworking fluid at a concentration of 0.01 to 0.10 percent of the total weight of the metalworking fluid. Where a higher concentration is required, use a working fluid, BFX 77 at a concentration which will provide .01 to .10 percent concentration which will provide .01 to .10 percent concentration of water for use.

Treatment of the diluted metalworking fluid should be repeated every 2 to 4 weeks as long as the metalworking fluid is used. More frequent treatment is required if excessive contamination occurs.

STORAGE AND DISPOSAL

Do not contaminate water, food, or feed by storage or disposal.

STORAGE: Do not stack more than four drums high. Leaking or damaged drums for disposal. Spills should be absorbed in sawdust or sand and the container closed when not in use.

PESTICIDE DISPOSAL: Wastes resulting from the use of this product should be disposed of through an approved waste disposal facility.

CONTAINER DISPOSAL:

PLASTIC: Triple rinse (or equivalent).
