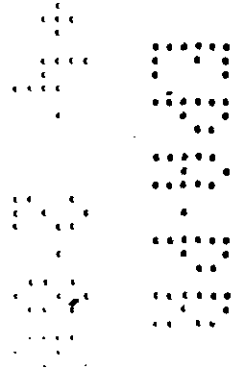

STATEMENT OF PRACTICAL TREATMENT

NOTE TO PHYSICIAN: Chlorpyrifos is a cholinesterase inhibitor. Treat symptomatically. Atropine is an antidote. IF SWALLOWED: Have patient drink 1 or 2 glasses of water and induce vomiting by touching back of throat with finger or blunt object. Do not induce vomiting or give anything by mouth to an unconscious person. Get medical attention. IF ON SKIN: Wash skin immediately with soap and warm water. IF IN EYES: Flush contaminated eyes with plenty of water and get medical attention if irritation persists.

DIRECTIONS FOR USE - GENERAL CLASSIFICATION

STORAGE AND DISPOSAL

Do not contaminate water, food or feed by storage or disposal.

STORAGE: Store only in original container, in an area inaccessible to children and pets. Keep lid tightly closed.

DISPOSAL: Do not reuse empty bottle. Wrap bottle and put in trash.

GENERAL: For use in and around homes, apartment buildings, institutional and commercial buildings, hospitals, stores and warehouses: Apply bait in teaspoon amounts in a suitable bait station. Locate stations where roaches have been observed, such as in cabinets, in closets, under sinks, refrigerators and water heaters. Place four to six bait stations per 100 sq. ft. of area. Replacement of bait should be made at four to six week intervals. Place stations in locations that are not accessible to children and domestic animals. Repeat as necessary. If German roaches (waterbugs) are the main target species, place bait stations at more frequent intervals for more effective control. May also be used as a scatter bait in areas not accessible to children and domestic animals such as under and/or behind stoves, refrigerators and water heaters.

FOR USE IN RESTAURANTS (INEDIBLE PRODUCT AREAS): Apply bait as stated in the general directions to such areas as restrooms, offices, closets, garbage rooms and storage rooms.

FOR USE IN RESTAURANTS (EDIBLE PRODUCT AREAS): When applying bait where food is prepared, processed or served, maintain strict account of location and number of bait stations. Do not apply bait in these areas until operations have ceased for the day. Remove all bait stations from these areas before operations resume.

FOR USE IN FEDERALLY INSPECTED FOOD PROCESSING PLANTS: Apply bait as stated in the general directions, but apply only in inedible product areas. Inedible product areas include garbage rooms, restrooms, offices, locker rooms, boiler rooms, garages, mop closets and storage rooms (after packaging, canning or bottling). Poultry receiving areas and livestock pens may be treated, but bait stations must be placed in a manner not accessible to animals.
