**DIRECTIONS FOR USE**

It is a violation of Federal law to use this product in a manner inconsistent with its labeling.

Read Entire Label.

For best results, spray in early morning or late evening when insect activity is minimal. Stand a safe distance from nest and not directly underneath. May cause staining (darkening) of asphalt surfaces and shingles. Hold can upright and point spray opening toward nest with wind at your back. Spray until nest is thoroughly saturated to kill the entire nest population. Residual action will kill wasps and hornets returning to the nest. Wait at least 24 hours before removing the nest.

To kill *wasps*, *hornets*, *yellow jackets* and *bees* under eaves, screens, window frames, doors, patios, cracks, holes or crevices wherever insects are noticed, spray for about 1 - 2 seconds or until surfaces are moist.

Do not apply to pets or contaminate feed, foodstuffs, dishes or utensils. Avoid spraying vegetation directly.

**STORAGE & DISPOSAL**

Do not contaminate water, food or feed by storage or disposal.

**Storage:** Do not store near heat or open flame. Store in cool dry area away from children.

**Disposal:** Do Not Puncture or Incinerate! *If empty:* Place in trash or offer for recycling if available.
