The amendment referred to above, submitted in connection with registration under the Federal Insecticide, Fungicide, and Rodenticide Act is acceptable provided that you make the labeling changes indicated below prior to release for shipment of product bearing the amended labeling.

- 1. The wording "Effective and Lasting Control," the word "Lasting" must be deleted or you must specify the length of time that is based upon supporting data.
- 2. The "Precautionary Statements" heading and wording should precede the "Directions for Use."
- 3. In addition, please revise the Precautionary Statements wording to read:

# PRECAUTIONARY STATEMENTS HAZARDS TO HUMANS AND DOMESTIC ANIMALS CAUTION

Harmful if swallowed or inhaled. Avoid breathing dust. Wash thoroughly with soap and water after handling. Avoid contact with eyes or clothing. Avoid contamination of foodstuffs. Do not treat kittens or puppies under 4 weeks old. Keep dust out of eyes

    to an unconscious or convulsing
    person.
