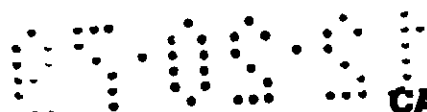

CAUTION

External:

For Skin: Wash with mild soap and water. Rinse with fresh water.

For Eyes: Rinse eye with water for at least 15 minutes. Get medical aid.

Internal:

If swallowed: Drink one or two glasses of water and induce vomiting by touching the back of the throat with a finger or blunt object. Do not induce vomiting or give anything by mouth to an unconscious person. Get medical attention.

If inhaled: Remove victim to fresh air. Apply respiration if necessary.

Keep out of the reach of children.

IMPORTANT

Do not apply (except as recommended) on or near susceptible plants, or in locations where the chemical may be washed or moved into contact with their roots.

When temperature exceeds 85°F or when wind velocity exceeds 10 mph there is a greater chance of herbicide particle movement to adjacent sensitive crops.

Applications by ground rigs, air and hand dispensers should be carried out only when there is no hazard from drift of product to susceptible plants such as beans, flowers, fruit trees, grapes, ornamentals, peas, potatoes, soybeans, sunflowers, tobacco, and tomatoes, during both the growing and dormant periods. Coarse sprays are less likely to drift.

Do not contaminate domestic or irrigation waters during application or by cleaning of equipment or disposal of wastes. Avoid contamination of feed and foodstuff. Thoroughly clean application equipment after use. Consult your state authorities for possible aerial or other application restrictions.

Observe all environmental cautions on labeling of all products used in mixtures.

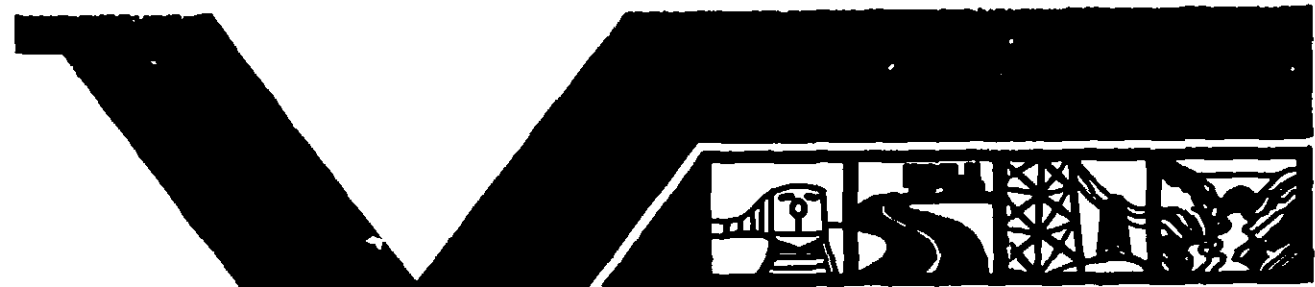

For milk-producing dairy animals, do not graze on treated land for 7 days after application of 0.5 lb. a.i./acre of dicamba, 40 days after application of 2.0 lb. a.i./acre of dicamba, after application of 4.0 lb. a.i./acre of dicamba.

For land treated with a Banvel plus 2,4,5-T tank mixture, do not graze dairy animals on treated land for 30 days of slaughter. Milk-producing dairy animals should not be grazed on treated land after application of up to 2 lbs. a.i./acre of dicamba. If dicamba is applied, do not graze dairy animals on treated land for 40 days.

IMPORTANT (Continued)

There are no grazing restrictions for cattle being produced for meat, on land treated with a Banvel plus 2,4-D tank mixture. For milk-producing dairy animals restrict grazing on treated land for 7 days after application of 0.5 lb. a.i./acre of dicamba, 21 days after application of 1.0 lb. a.i./acre of dicamba, 40 days after application of 2.0 lb. a.i./acre of dicamba, and 60 days after application of 4.0 lb. a.i./acre of dicamba.

For land treated with a Banvel plus 2,4,5-T tank mixture, do not graze meat animals within 30 days of slaughter. Milk-producing dairy animals should not graze treated fields until 42 days after application of up to 2 lbs. a.i./acre of dicamba. For rates of over 2.0 lbs. a.i./acre of dicamba, do not graze dairy animals on treated land for 60 days after application.
