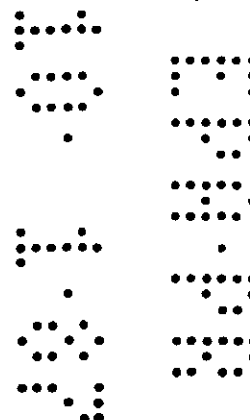

ENVIRONMENTAL HAZARDS

STORAGE AND DISPOSAL

STORAGE: Pesticides must be stored away from other products, food or feed. Store away from direct sunlight or heat. In case of spill or leak, soak up with soil or other absorbent material.

DIRECTIONS FOR USE

SHAKE WELL BEFORE USING

It is a violation of Federal Law to use this product in a manner inconsistent with its labeling.

Add PENTAC AQUAFLOW to water at recommended rates and mix well before spraying. Maintain agitation or agitate frequently while spraying. Use dilute spray mixture within 24 hours. Commonly used spreader-type spray adjuvants (except those intended for herbicide use) may be added to tank mix to enhance leaf surface wetting on hard-to-wet foliage, if needed.

It is important to assure complete coverage by spraying foliage to run-off, thoroughly wetting upper and lower leaf surfaces.

When heavy mite populations occur, usually during hot weather, a second application at the following interval is recommended for optimum control:

USE	APPLICATION INTERVAL
Outdoor	5 days
Greenhouse & Shadehouse	7 days
Interior & Plantscape	7 days

To reduce likelihood of resistance, alternate treatments with MAVRIK AQUAFLOW® Insecticide (5 oz./100 gallon) or treat with a tank mix of PENTAC AQUAFLOW and MAVRIK AQUAFLOW.

GREENHOUSE AND SHADEHOUSE USE

Apply PENTAC AQUAFLOW at 8 fluid ounces (1/2 pint) in 100 gallons of water (65 ml per 100 liters). Add recommended amount of PENTAC AQUAFLOW to partially filled tank of water, then complete filling and mix well before spraying.

NURSERY STOCK

For control of mites on nursery stock, apply PENTAC AQUAFLOW before or after budding at 8 to 16 fluid ounces/100 gallon, thoroughly covering foliage.

For use on non-bearing fruit and nut stock*, apply in a similar manner.

*Except in California

EXTERIOR LANDSCAPE PLANTINGS

Apply PENTAC AQUAFLOW at 12 to 16 fluid ounces per acre (0.9 - 1.2 litre per hectare) in sufficient water to thoroughly wet foliage to run-off. The higher rates are recommended under conditions of higher temperatures or severe mite pressure. Use of drop nozzles angled to direct spray upwards under leaves is recommended to assure complete coverage of upper and lower leaf surfaces.

INTERIOR AND PLANTScape USE

Apply PENTAC AQUAFLOW at 0.1 fluid ounce (2/3 teaspoon) per gallon (0.75 ml per liter) of water. Mix well before spraying. It is important to assure complete coverage by spraying foliage to run-off, thoroughly wetting upper and lower leaf surfaces.

Avoid spraying wallcoverings, plastic (vinyl) surfaces, drapes, carpets, and upholstery.
