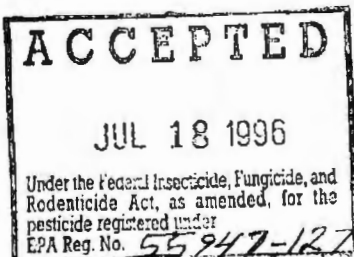

3. Apply a fine mist by depressing plunger quickly and firmly.
4. Mist for complete coverage of all plant surfaces, including underside of leaves: minimize runoff or drip.
