Mixing instructions: Dilute 1 kg of concentrate with 49 kg of deionized water containing 0.1 kg Potassium Sorbate and 0.03 kg Methylparaben. Adjust pH to 6.3 ± 0.2 with sodium hydroxide (approximately 25 gm).

Use patterns: Each formulated insecticide product must be registered with the Environmental Protection Agency. Formulators using this product are responsible for supplying data as required by EPA regulations in support of each registration. It is the responsibility of the repackager to obtain this registration. Sandoz Agro Inc. has provided portions of this information. See Technical Data Bulletin for references to this data and conditions of use.

STORAGE AND DISPOSAL:

Avoid storage in conditions of extreme heat.
