Follow-up applications are recommended when egg hatch occurs ever an extended period, such as when edult moth flight and egg laying continue for a week or more. Satisfactory control cannot be expected if treatment is delayed past the second instar or after larvae have begun entering the plant. Best results will be achieved when moisture from dew, reinfall or irrigation shortly follows application.
