The amendment referred to above, submitted in connection with registration under the Federal Insecticide, Fungicide and Rodenticide Act (FIFRA), as amended is acceptable provided that you:

- 1. Make the labeling changes listed below before you release the product for shipment bearing the amended labeling:
 - a. You should delete AVISO and the Spanish Language Text. AVISO and Spanish Text are only required for products subject to the Agricultural Worker Protection Standard. This product is For Manufacturing Use Only.
 - b. In the Hazards to Humans section delete "AVISO". Modify the text to read:

May be fatal if swallowed. Harmful if absorbed through skin. Prolonged or frequently repeated skin contact my cause allergic reaction in some individuals. Avoid contact with skin, eyes or clothing. Wash thoroughly with soap and water after handling and before eating, drinking or using tobacco. Remove contaminated clothing and wash before reuse.

c. Modify the Statement of Practical Treatment section to read as follows:

IF SWALLOWED: Call a physician or Poison Control Center. Drink 1 or 2 glasses of water and induce vomiting by touching back of throat with finger. If person is unconscious, do not give anything by

mouth and do not induce vomiting.

IF ON SKIN: - Wash with plenty of soap and water. Get medical attention.

IF IN EYES: Flush eyes with plenty of water. Call a physician if irritation persists.

IF INHALED: Remove victim to fresh air. If not breathing, give artificial respiration, preferably mouth to mouth. Get medical attention.

- d. When printing the label verify that the symbol for degree is used i.e. "60°F" in the Storage and Disposal Section. On the draft label it appears as 600.
- e. In the warranty statement you should delete references to crop injury, ineffectiveness, and weather conditions since this is a manufacturing use product.
- 2. Submit one (1) copy of your final printed labeling before you release the product for shipment.

A stamped copy of the labeling is enclosed for your records. The revised labeling supersedes all previously accepted ones. For your assistance enclosed is a copy of the review of the 6(a)(2) studies by Precautionary Review Section, Registration Support Division.
