The labeling cited above and submitted in connection with registration under the Federal Insecticide, Fungicide, and Rodenticide Act (FIFRA), as amended, is accepted subject to the comments reflected on the enclosed sheet. #### WHAT THIS ACCEPTANCE MEANS:

#### AGRICULTURAL USE REQUIREMENTS:

Use this product only in accordance with its labeling and with the Worker Protection Standard, 40 CFR part 170. This Standard contains requirements for the protection of agricultural workers on farms, forests, nurseries, and greenhouses, and handlers of agricultural pesticides. #### WHERE TO USE

CEDAR CHEMICAL'S WHAM! DF 80 is used for postemergence control of broadleaf and grass weeds in RICE fields. Do Not apply this product (directly or indirectly) to any crop except rice.

#### WEEDS CONTROLLED

Barnyardgrass, (watergrass), signalgrass(brachiaris), coffeeweed, crabgrass, croton, curly indigo, foxtail, goosegrass, gulf cockspur, mexicanweed, millet(Texas), paragrass, pigweed, sourdock, spearhead, wiregrass.

(WHAM! DF 80 will not control arrowhead, bermudagrass, cattail, ducksalad, johnsongrass, nutgrass, red rice and sprangletop.)

#### GENERAL INFORMATION

Several important factors should be taken into account to achieve a high efficiency of selective weed control with WHAM! DF 80. These include uniform application, growth stage and weather conditions. To assure uniform application mix the prescribed amount of WHAM! DF 80 with a sufficient volume of water to provide thorough coverage of target area. For aerial application use approximately 10 gallons of water, or for surface (ground) applications 20-30 gallons of water per acre at sufficient spray pressure. Agitate tank mixes thoroughly and continuously. Avoid over and under application.

Growth stage of weeds is very important. Best results for selective weed control are obtained when most grasses have reached the 1 to 3 leaf stage. Proper field preparation is essential to ascertain a relatively clod free and level surface to obtain uniform flood levels and growth. Fields may be flushed prior to treatment to produce uniform and vigorous grass germination and growth. Drain water from fields prior to applying WHAM! DF 80. Higher rates are recommended to control larger grasses or exposed weeds when rice fields are not completely drained. Inspect rice fields regularly to select the correct application time.

DO NOT APPLY THIS PRODUCT THROUGH ANY TYPE OF IRRIGATION SYSTEM.

Do not apply to fields where commercial catfish farming practiced and do not drain water from treated fields into a where catfish farming is practiced.

Do not apply when wind conditions will allow drift to adjace susceptible crops such as beans, soybeans, cotton, saffle cucurbits, vegetables, orchards (such as almonds, prunes, grapes) and other sensitive crops.

Weather Conditions: WHAM! DF 80 normally requires 8 hours DIRECT sunlight for absorption into target weeds. However atmospheric and environmental factors can affect absorption the target weed. It is highly recommended that application WHAM!DF 80 be planned so that the applied product remains contact with the leaf surfaces for at least 48 hours prior rainfall. Historically, morning applications of propanil productioning WHAM! DF 80 have produced better results in weed contact wham! DF 80 is less susceptible to drift than solve based propanil products, application should be avoided if velocity is high enough to cause drift or irregular spray patterns.

Use of Crop Oils and Surfactants: When WHAM! DF 80 is used a (not in combination with any other postemergent rice herbicida low viscosity crop oil concentrate or surfactant may be use improve wetting of foliage and weed control. Use of a crop concentrate is recommended when application is made during weather conditions or unstable weather conditions that may provain. Under adverse weather conditions, the addition of a crop concentrate when tank mixing WHAM! DF 80 and other rice herbic for application should be considered. Consult product labels adjuvant recommendations. The use of a suitable crop concentrate or surfactant does not significantly increase injurrice (leaftip burn).

#### RECOMMENDED BROADCAST RATE WHAM! DF 80

Apply 3½ pounds of WHAM! DF 80 per acre when most grasses reached 1 to 3 leaf stage. Use 5 to 7½ pounds of WHAM! DF 80 acre when the grasses are large (4 to 6 leaf stage) or unseasonably cool weather conditions prevail or in cases where fields have not been drained completely and where weeds are 1s

Barnyardgrass may be controlled up to 30 to 45 days after plant before rice plants have reached the fully tillered growth sta

NOTE: WHAM! DF 80 applied to rice after the 4 leaf stage may of visible injury under some climatic conditions. Rice plants usu outgrow such injury.

NOTE: Water drained from treated rice fields must not be used to irrigate other crops or be released within a mile upstream of a potable water intake in flowing water (i.e. river, stream, etc.) or within a mile of a potable water intake in a standing body of water such as a lake, pond or reservoir.

IN CALIFORNIA: Use WHAM! DF 80 only where rice fields are not completely drained. If higher water level is desired, reflood field after 12 hours and before 7 days after treatment. This will discourage new weed infestations. Do not apply WHAM! DF 80 within 14 days before or after insecticide applications. Serious injury to rice may occur.
