

SLIME AWAY is used in recirculating commercial and industrial water cooling systems must be cleaned to remove algal growth, other deposits. An initial slug addition of 6.9 SLIME AWAY per 1000 gallons is recommended. Repeat initial dosage until control is evident. Subsequent slug additions of 2.3 to SLIME AWAY per 1000 gallons every 1 to 5 days, or as needed. The frequency of relative amount of bleedoff and the severity of the m additions should be made in the sump of water cooling

STORAGE AND DISPOSAL

Do not contaminate water, food, or feed by storage. **STORAGE:** Do not expose to extreme temperatures. Do not store more than five drums high. Drums should be opened in well-ventilated areas. Damaged drums should be placed in overpack drums and disposed of in a container closed when not in use.
