

WARNING: Causes eye damage and skin irritation. Do not get in eyes, on skin, or on clothing. Wear goggles or face shield and rubber gloves when handling. Harmful or fatal if swallowed. Avoid contamination of food.

STATEMENT OF PRACTICAL TREATMENT: in case of contact, immediately flush eyes or skin with plenty of water for at least 15 minutes. For eyes, call a physician. DIRECTIONS FOR USE

It is a violation of Federal law to use this product inconsistent with its labeling.

SLIME AWAY PLUS is used in recirculating commercial and industrial water cooling systems must be cleaned to remove algal growth and other deposits. An initial slug addition of 3.3 SLIME AWAY PLUS per 1000 gallons is recommended. Repeat initial dosage until control is evident. Subsequent slug additions of 1.1 to SLIME AWAY PLUS per 1000 gallons every 1 to 5 days, or as needed. The frequency and relative amount of bleedoff and the severity of the additions should be made in the sump of water cooling

STORAGE AND DISPOSAL

Do not contaminate water, food, or feed by storage or disposal. STORAGE: Do not expose to extreme temperatures. Do not store more than five drums high. Drums should be opened in well-ventilated areas. Damaged drums should be placed in overpack drums and not be absorbed in sawdust or sand and disposed of in a container closed when not in use.

PESTICIDE DISPOSAL: Pesticide wastes are considered hazardous. Do not use excess pesticide, spray mixture, or rinsate.
