PRECAUTIONARY STATEMENTS
Hazards to Humans and Domestic Animals

CAUTION: Harmful if inhaled. Avoid contact with skin, eyes or clothing. Wash contaminated skin promptly with soap and warm water. Wash hands with soap and water after using or before eating or smoking. Do not allow children or pets to contact treated surfaces until spray has dried. Do not spray air in rooms or use on plants. Apply as a surface spray only. Do not allow spray to contact food, feedstuffs or water supplies. Thoroughly wash dishes and food handling utensils contaminated with this products. Remove pets and cover fish bowls before spraying.

STATEMENT OF PRACTICAL TREATMENT: IF ON SKIN: In case of contact, remove contaminated clothing and immediately wash skin with soap and water. Wash clothes before reuse. IF IN EYES: Flush eyes with water for 10-15 minutes. Call a physician if irritation persists. IF INHALED: Remove victim to fresh air. Apply artificial respiration if indicated. Give nothing by mouth to an unconscious person.

NOTE TO PHYSICIAN: Chlorpyrifos is a cholinesterase inhibitor. Atrophin: only by injection is antidotal.

STORAGE AND DISPOSAL: STORAGE: Store in original container in a cool dry place inaccessible to children or pets. DISPOSAL: Wrap container in several layers of newspaper and dispose in trash. Do not puncture or incinerate.

DIRECTIONS FOR USE: It is a violation of Federal Law to use this product in a manner inconsistent with its labeling.

To operate, hold can upright, direct orifice toward the surface to be treated and press the actuator button. Do not use as a space spray. SHAKE WELL BEFORE USING.

To kill ants, carpet beetles, centipedes, cockroaches, crickets, earwigs, firebrats, pillbugs, silverfish and spiders: thoroughly apply as a spot treatment to areas where these pests are found or may hide, including dark corners or rooms and closets, cracks and crevices, under carpets, along baseboards and door sills and frames; behind and beneath sinks, stoves, refrigerators, and cabinets and around garbage cans, plumbing and other utility installations. Pests driven out of hiding places should be sprayed directly. Spray ant trails, nests and points of entry.

To kill brown dog ticks and fleas: apply thoroughly as a spot treatment to infested areas such as pet beds and resting quarters, and nearby cracks and crevices; along and behind baseboards, window and door frames and localized areas of floor and floor covering where these pests may be present. Fresh bedding should be placed in animal quarters following treatment. Do Not Spray Pets With This Products.

To control flies, gnats, hornets, mosquitoes, small flying moths, wasps and yellow jackets: use only on outdoor surfaces. Spray outside surfaces of window and door frames and other areas where these pests may enter the home. Also spray dark corners and localized resting area, such as under eaves, porches, partitions and in garages where these insects may congregate. Flies and mosquitoes coming to rest on treated surfaces will be killed. Repeat treatment when effectiveness diminishes.
