

in recirculating commercial and industrial water systems must be cleaned to remove algal and other deposits. An initial slug addition of 5 H-5000 ALGAECIDE per 1000 gallons is recommended. Repeat initial dosage until control is achieved.

Subsequent slug additions of 1.7 H-5000 ALGAECIDE per 1000 gallons every 1 to 5 days, or as needed. The frequency of additions should be made in the sump of water.

STORAGE AND DISPOSAL
