PRECAUTIONARY STATEMENTS

HAZARDS TO HUMANS AND ANIMALS

CAUTION:

Harmful if swallowed, ~~or absorbed through skin.~~ Avoid contact with eyes, ~~skin or clothing.~~ Wash hands thoroughly with soap and water after handling.

This shampoo is intended for external use on dogs (cats) only and is not to be taken internally by man or animal. Not intended for use on humans. Do not allow children to handle or play with this product. Do not bring into contact with food, cooking utensils or food preparation surfaces.

Some animals and humans may be sensitive to this shampoo. Discontinue use at first sign of irritation or adverse reaction. Do not use on sick or convalescing animals.

STATEMENT OF PRACTICAL TREATMENT

IF SWALLOWED: *Drink 1 or 2 glasses of water and induce vomiting by touching*
~~Do not induce vomiting. CALL A PHYSICIAN OR POISON CONTROL CENTER IMMEDIATELY.~~ *to back of throat with finger,*
IF ON SKIN: ~~Wash with plenty of soap and water. Get medical attention if irritation persists~~
IF IN EYES: Flush with water immediately. Get medial attention if irritation persists.

ENVIRONMENTAL HAZARDS:

This product is toxic to fish. Keep out of lakes. Do not wash animals where runoff is likely to occur.

DIRECTIONS FOR USE:

It is a violation of Federal law to use this shampoo in a manner inconsistent with its labeling

Thoroughly soak animal with warm water taking 2-3 minutes to wet hair. Apply Beaphar Shampoo on head and ears and lather head and ears; then repeat procedure with neck, chest, middle and hind quarters, finishing legs last. Let animal stand 3-5 minutes (this is an important procedure), then rinse animal thoroughly. In extremely dirty or scaly animals the above procedure may be repeated. This shampoo may be used every 7-10 days. Do not use on nursing bitches or puppies under 6 weeks of age. Dry animals thoroughly after rinsing.

STORAGE AND DISPOSAL:

Store in a cool place. Do not reuse empty container. Wrap empty container and put in trash collection.
