

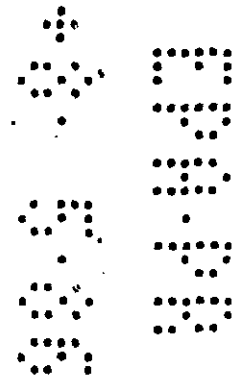

Directions for Use:

Remove a tablet from the foil and place on a vapouriser. Switch on vapouriser. Each mat will keep you free from mosquitos for up to 10 hours. Do not re-use tablets. Change tablet when it turns white.

Cautions:

The vapouriser should be placed on the floor or other non combustible surface. The vapouriser should not be in operation while people are sleeping. No more than one unit is to be used per 8' x 8' x 8' room. Do not allow the product to come into contact with food, drinks, or kitchen utensils.

Storage & Disposal:

Store in a dry place, out of reach of children. Wrap and place the spent tablet in trash collection.
