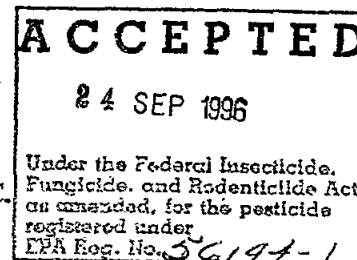

WHAT IS IT: Diatomaceous earth is made up of fossilized deposits of algae called diatoms. Diatoms weave tiny shells out of the silica they extract from water. As they die, their shells become fossilized into diatomaceous earth (D.E.) or diatomite.

HOW DOES IT WORK: The microscopic sharp shells of diatomite scratch the wax coating of the insect's skeleton causing the insect to lose moisture and die. D.E. does not kill instantly. Death by dehydration takes about 12 hours.

DIRECTIONS FOR USE

INDOORS

Apply a thin layer of dust in areas where these pests are found or suspected of hiding, such as in cracks and crevices; behind and beneath appliances, furniture, sinks, cabinets and waste containers; around pipes and drains; on window frames; and in attics and basements. Where possible, treat insects directly. Repeat treatment as necessary.

OUTDOORS

Apply a thin layer of dust in areas where these pests are found or suspected of hiding, including patios, windows, door frames and sills, outside of entrance ways, around foundations and along ant hills and trails. Where possible, treat insects directly. Repeat treatment as necessary.

Storage: Store in a cool, dry place inaccessible to children and pets. Disposal: Do not reuse empty container; wrap and put in trash.
