2. Make the labeling changes listed below before you release the product for shipment:

- a. Add the phrase, "EPA Registration No. 56194-2".
- b. Add the following instructions under the Directions for Use

Adjust moisture content of grain to not over 12% by weight, and add 7 lbs of this product per ton of grain at the point of entry into storage. Treated grain may be reduced to a lower grade, have reduced flowability and test weight. For best results, treat grain immediately after harvest.

- c. Revise the last statement under the precautionary statements to read as follows:

Wear a dust mask when using this product during prolonged exposure.

- d. Add the Pesticide Disposal section to the Storage and Disposal section as follows:

Pesticide Disposal: Do not contaminate water, food or feed by storage and disposal. Wastes resulting from use of this product may be disposed of on site or at an approved waste disposal facility.

- e. Add the statement "Recommended for Commercial/Industrial Use Only" on the front label panel.

- f. Delete the statement, "After dusting there is no need to wait to store grain, as Insect-Away is completely safe after application." Claims as to the safety of a pesticide or its ingredients in any form are unacceptable.

- g. Add the word **grain** in the statement "An Effective Addition for the Control of **Grain** Insects."

3. Submit five copies of your final printed labeling before you release the product for shipment. Refer to the A-79 Enclosure for a further description of final printed labeling.

If these conditions are not complied with, the registration will be subject to cancellation in accordance with FIFRA sec. 6(e). Your release for shipment of the product constitutes acceptance of these conditions.

DIRECTIONS FOR USE

It is a violation of Federal Law to use this product in a manner inconsistent with its labeling.

Insect-Away! is an effective soil killer for insects such as Red Flour Beetles, Rice Weevils, Granary Weevils, Armyworms, Grain Moths, Mediterranean Flour Weevils, Indian Meal Moths, etc.

Insect-Away! should be distributed at a rate of approximately one (1) pound per 1,000 sq. ft. on all interior surfaces of empty areas. After dusting there is no need to store grains, as **Insect-Away!** is completely safe after application. It is recommended that previously untreated areas be undisturbed for one to two days to allow existing insects to die. Also, **Insect-Away!** should be re-applied each time a structure is emptied.

Insect-Away! is also effective for use in Transit. To apply, clean and dust ship holds and truck beds before use. Thoroughly treat walls, and floors, lightly after grain is loaded.

TREATMENT OF STORED GRAIN results, treat grain immediately after application. Apply **Insect-Away!** to grain at a rate of one pound per ton of grain to prevent it from damage.
