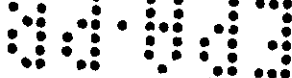

DIRECTIONS FOR USE

It is a violation of Federal law to use this product in a manner inconsistent with its labeling.

GLACIDE 515 is used to control bacteria and fungi in recirculating commercial and industrial air wash systems. To insure its use, systems must be cleaned to remove slime, and other deposits. An initial slug addition of GLACIDE 515 fluid ounces of _____

per 1000 gallons of water to provide a concentration of 48 GLACIDE 515 in the system, is recommended. Repeat initial slug additions of 1.53 GLACIDE 515 per 1000

gallons of water to provide a concentration of 120 parts per million of GLACIDE 515

employed every 2 to 5 days, or as needed. The frequency of addition depends upon the relative amount of bleedoff and the severity of the bacterial problem. Slug additions should be made in the slug collection trays of the airwash system.

GLACIDE 515 is used to control bacteria and fungi in recirculating commercial and industrial air wash systems. To insure its use, systems should be cleaned to remove slime, and other deposits. An initial slug dose of 24.7 GLACIDE 515 per 1000

gallons of water to provide a concentration of 16.9 to 41.2 fluid ounces of GLACIDE 515 per 1000 gallons of water should be employed. Repeat initial dosage until control is achieved. The frequency of addition depends upon the relative amount of bleedoff and the severity of the bacterial problem. Slug additions may be made in the slug collection trays of the airwash system.

STORAGE AND DISPOSAL

Do not contaminate water, food, or feed by storage or disposal. STORAGE: Do not stack more than four drums high. Leaking drums for disposal. Spills should be absorbed in sawdust or similar material. Container closed when not in use.

PESTICIDE DISPOSAL: Wastes resulting from the use of this pesticide should be disposed of at a government approved waste disposal facility.

CONTAINER DISPOSAL:

PLASTIC Triple rinse (or equivalent). Then offer for recycling (where available) or for sanitary landfill, by incineration, or, if allowed by state and local authorities, by other procedures approved by state and local authorities.
