

## DIRECTIONS FOR USE

It is a violation of Federal law to use this pesticide inconsistent with its labeling.

GLACIDE 525 is used in recirculating commercial and industrial water systems must be cleaned to remove algal growth and other deposits. An initial slug addition of 6 GLACIDE 525 per 1000 gallons is recommended. Repeat initial dosage until control is achieved. Subsequent slug additions of 2.3 GLACIDE 525 per 1000 gallons every 1 to 5 days, or as needed. The frequency of additions should be made in the sump of water.

## STORAGE AND DISPOSAL

Do not contaminate water, food, or feed by storage or disposal.
