We have reviewed Poherta J. Pohl's letter of October 28, 1996, and concur with its basic premise that the September 27, 1996, amendment to the Strychnine Settlement Agreement permits us to consider acceptance of the proposed revised label submitted for this product on October 2, 1995. We have decided to accept that label, provided that you comply with the conditions stipulated below.

- 1. In the third sentence of the "ENVIRONMENTAL HAZARDS" section change "where runoff is likely to occur" to "below the mean high water mark". The latter phrase is taken directly from PR Notice 93-3.
- 2. Submit one copy of final printed labeling for our files before releasing this product for shipment

As noted in our letter of August 23, 1996, you must provide certain product chemistry data on the new formulation of this product. The data requirements which must be met are Description of Beginning Materials and Manufacturing Process (Guideline No. 61-2), Density (63-7), and Storage Stability (63-17).



STATEMENT OF PRACTICAL TREATMENT IF SWALLOWED: CALL A PHYSICIAN OR POISON CONTROL CENTER IMMEDIATELYI

If less than ten (10) minutes have passed since the poison was taken, give 1 or 2 glasses of water and induce vomiting by touching back of throat with finger. Repeat until vomit fluid is clear. Have patient lie down in quiet, darkened room and keep him warm and quiet. Do not induce vomiting or give anything by mouth to an unconscious person.
